- Conditional tenders shall not be accepted on any ground and shall be rejected straight away.

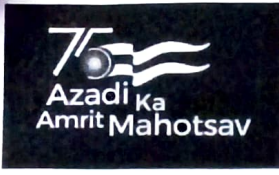

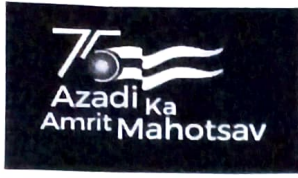
