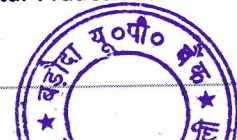

- The Rate Contract with the selected vendor will be valid up to a period of two Year from the date of acceptance of the rates.
- The contract will be effective **for one year** and may be renewed on expiry for further period of one next year.
- **Security Deposit/Retention Money:** Security Deposit/Retention Money of 5% of total AMC value has to be submitted by the way of Demand Draft/Banker's Cheque/Pay Order drawn in favour of "Baroda UP Bank" payable at Chandauli. Security Deposit/Retention Money will not carry any interest. It will be released after completion of AMC period of one year from date of AMC agreement.
- Maintenance charges include all taxes and government levies as applicable (Other than GST) or becoming applicable later due to operation of or under any existing or new laws. The taxes & govt. levies whatsoever (Other than GST) be borne by the vendor.
- The contract will be on non-comprehensive onsite maintenance.
- The maintenance service includes preventive and corrective maintenance of the Alert Alarm System. Preventive maintenance should be carried out on quarterly basis. Preventative maintenance Include cleaning of internal circuit board with all parts and all other measures necessary for proper functioning of the machine. Corrective maintenance includes repairing/replacement of the machine spares parts.
- The vendor should provide dedicated resident engineer, who will act as single point contact over phone, He will be responsible for point contact over Phone, Email and/or

- The number of Alert Alarm System as given in Annexure-B is the tentative number, the final number will be provided by the Bank at the time of agreement.
- The Bank reserves the right to claim as damages from the vendor to the extent of the loss suffered by it, if it is found that due to any commission or omissions of the vendor, damage has been caused to equipment covered by the AMC or to any property of the Bank even if it is not covered by the AMC.
- The Bank reserves the right to terminate the agreement of AMC, if the vendor fails to carry out any of its obligations/duties in terms of the agreement.
- The Bank shall not consider any request in change of rates of AMC due to any reason whatsoever, during the period of the contract.
- The Bank is fully empowered to change any of these conditions, if wanted, at any point of time.
- Bank reserves the right to accept or reject any quotation without assigning any reason whatsoever.
- Bank is not bound to accept lowest or any proposal received.
- Final decision will be taken after analysing cost.
- Any dispute will be under Chandauli jurisdiction.

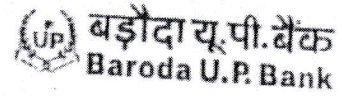

अन्य नियम व शर्तें

1. सफल वेण्डर/फर्म/कम्पनी को क्षेत्रीय कार्यालयों द्वारा कार्य आदेश जारी किया जायेगा तथा त्रैमासिक आधार पर प्रो-रेटा भुगतान भी उनके द्वारा किया जायेगा.
2. वेण्डर द्वारा प्रत्येक त्रैमास में शाखाओं/कार्यालयों की न्यूनतम एक विजिट करना अनिवार्य होगा. इसके अतिरिक्त जब भी सीसीटीवी/अलर्ट अलार्म में किसी खराबी की सूचना शाखा/क्षेत्रीय कार्यालय द्वारा दी जायेगी तो उसे अधिकतम 24 से 48 घंटे के अंदर अटेंड करना अनिवार्य होगा. वेण्डर को शिकायत दर्ज कराने हेतु एक डेडीकैटेड ई-मेल आइडी एवं मोबाइल/फोन नम्बर उपलब्ध कराना होगा.
3. कार्य आदेश जारी होने के प्रथम त्रैमास में वेण्डर को क्षेत्र की सभी शाखाओं/कार्यालयों का भ्रमण करके सीसीटीवी/अलर्ट अलार्म का मेक-माडल व अन्य विवरण का डेटा तैयार करना होगा जिसकी एक प्रति सम्बन्धित क्षेत्रीय कार्यालय में जमा करना होगा.
4. वेण्डर/फर्म/कम्पनी को प्रत्येक त्रैमास की समाप्ति के उपरांत बिल का भुगतान क्षेत्रीय कार्यालयों द्वारा किया जायेगा. वेण्डर को त्रैमास की समाप्ति के बाद एक सप्ताह के भीतर शाखाओं/कार्यालयों की विजिट रिपोर्ट (शाखा प्रबंधक के हस्ताक्षर व मुहर सहित) के साथ जीएसटी बिल प्रस्तुत करना होगा.
5. यदि किसी शाखा/कार्यालय में लगे सीसीटीवी/अलर्ट अलार्म में पार्ट्स बदलना आवश्यक हो तो वेण्डर द्वारा अनुमोदित न्यूनतम दरों के अनुसार ई-मेल द्वारा इस्टीमेट सम्बन्धित क्षेत्रीय कार्यालय को प्रेषित करना होगा. सम्बन्धित क्षेत्रीय कार्यालय द्वारा ई-मेल से अनुमोदन प्राप्त होने के बाद पार्ट्स बदलने की कार्यवाही की जायेगी तथा इसका बिल त्रैमास की समाप्ति के बाद एएमसी बिल के साथ प्रस्तुत करना होगा.
